2018 Fees

- A deposit of the full amount of your \$40 fee is required to reserve space. Space will not be reserved until this deposit is received.
- Please make all checks payable to **Walnut Creek Business Association, PO Box 20 Walnut Creek, OH 44687**

Terms and Conditions

- For the purpose of set up, the Vendor shall have access to the space 1 day prior to the Event.
- Host will assign booth space.
- Food Vendors must supply their own tent, if needed.
- Booth rental fee does not include electricity. Food vendors may bring a generator.
- Host reserves the right to request the removal of offensive or inappropriate merchandise that is considered unsuitable for the Event.
- The Vendor shall have access to the space until Saturday, July 29th at 8 pm in order to dismantle their display and remove all unsold items brought to the Event by the Vendor.
- The Vendor shall leave the location free of trash and in the condition in which it was found upon their arrival and prior to set up.
- Food Vendors are responsible to have all permits and licenses required to sell food.
- The Vendor hereby agrees to hold harmless the Host against any damages or claims that may arise in connection with the Vendor's presence at the Event including damages or claims of theft resulting from the Vendor's activities of any kind.
- Food Vendor vehicles (aside from the trailer you are serving from) must be parked in designated parking. We do not want extra cars on the show floor. Please remove by 6:30 the morning of the event.
