Eligible items should be ready to upcycle, reclaim, restore or reuse. Or, your items may be already restored vintage pieces. Select hand-made items accepted, as well.

Items that are not vintage-inspired may be rejected by the host.

No direct sales items will be accepted.

Examples—Old bicycles, old doors, quilts and textiles, canning jars, pallet furniture/décor, repurposed furniture items, hand made clothes and other items with vintage fabrics, hand made candles and bath items and hand made vintage décor.

Fees Full payment of booth space is required to reserve a spot. Booth sizes are 100 Square Feet, 200 Square Feet and 300 Square Feet

Event is rain or shine. Booths are available under tent or outside.

Space is limited.

2019 Walnut Creek Vintage Fair Vendor Requirements

2019 Fees

- Depending on the booth size selected, a deposit of the full amount of your fee is required to reserve space. Space will not be reserved until this deposit is received.
- 100 square foot Booth-\$65 UNDER TENT
- 200 square foot Booth-\$100 UNDER TENT
- 300 square foot Booth-\$140 UNDER TENT
- 200 square foot Booth-\$85 OUTSIDE
- 300 square foot Booth-\$110 OUTSIDE

- Deadline for payment is May 30, 2019. After the deadline, if booth space is still available, spaces will be sold at \$140 per 100 square foot space. Booth size will be assigned by the host according to availability.

Terms and Conditions

As per the contract,

- For the purpose of set up, the Vendor shall have access to the space the day before the event from 12:00-7:00.
- Host will assign booth spaces. Please, no special requests.
- Booth rental fee does not include electricity.
- Vendors may not sell out of a truck, van or other vehicle.
- All vehicles must be off of the show grounds by 6:30 am. Absolutely no Vendor Vehicles on the show floor during the show. No closing up and loading before 3:00.
- Vendor's vehicles must be parked in designated parking lot which is behind the tent.
- Host reserves right to request the removal of offensive or inappropriate merchandise that is considered unsuitable for the Event.
- The Vendor shall have access to the space until Saturday, June 29 at 8:00 pm in order to dismantle their display and remove all unsold items brought to the Event by the Vendor.
- The Vendor shall leave the location free of trash and in the condition in which it was found upon their arrival and prior to set up. Please plan ahead to take care of your own trash by bringing along items needed to dispose of trash (trash bags, etc.).
- The Vendor hereby agrees to hold harmless the Host against any damages or claims that may arise in connection with Vendor's presence at the Event including damages or claims of theft resulting from the Vendor's activities of any kind.
- Booth contract may be transferred but not canceled. Transfer is the responsibility of the contract holder. No refunds will be issued after the contract has been received. Sorry, no exceptions.
- Vendor is responsible for collection and payment of sales tax.
- Camping at the show grounds is prohibited. There are several camp grounds near the show grounds. If you'd like more information, please email us, we are happy to give you a list of options.
- No pets allowed. Service animals only.

Thank you for complying with the terms, it helps us run a successful and organized show. We reserve the right to bar any vendor who chooses not to follow the Vintage Fair terms and conditions.

- 200 Square Feet-10' x 20' (\$85.00) OUTSIDE (NO TENT)
- 300 Square Feet-10' x 30' (\$110.00) OUTSIDE (NO TENT)
